Panasonic Projector Systems Company or Panasonic Puerto Rico, Inc., (collectively referred to as “the Warrantor”) will repair this product and all included accessories with new or refurbished parts, free of charge in the USA or Puerto Rico, of the original purchase in the event of a defect in materials or workmanship as follows:

Carry-in or mail-in service in Puerto Rico can be obtained during the warranty period by calling the number listed in the Service Center Directory.

This warranty is extended only to the original purchaser and is non-transferable. A purchase receipt or other proof of date of original purchase will be required before warranty service is rendered.

This warranty only covers failures due to defects in materials or workmanship that occurs during normal use. The warranty does not cover damage that occurs in shipment, failures that are caused by products not supplied by the warrantor, failures that result from accident, misuse, abuse, neglect, mishandling, misapplication, alteration, modification, faulty installation, setup adjustments, improper antenna, inadequate signal pickup, maladjustment of consumer controls, improper operation, power line surge, improper voltage supply, lighting damage, service by anyone other than an authorized repair facility, or damages attributable to acts of nature.
